STATE NOTICES

CALIFORNIA: A married applicant may apply for a separate account. If your credit request is declined, you refuse or counter offer, your account is terminated or there is an unfavorable change in terms made to your account and our decision is based, in whole or part, on information contained in a consumer credit report, you have the right to obtain a copy of your consumer credit report from the credit reporting agency within 60 days. You also have the right to obtain a copy of your consumer credit report from any other credit reporting agency which compiles and maintains files on a nationwide basis. Additionally, you have the right to dispute the accuracy or completeness of any information in a consumer credit reporting agency. (California Civil Code Sec. 1785.20).

MAINE: Consumer credit reports may be obtained in connection with this Application. If you request, (1) you will be informed whether or not consumer reports were obtained; and (2) if reports were obtained you will be informed of the names and addresses of the consumer reporting agencies (credit bureaus) that furnished the reports. (Public Law Chapter 453 (1991)).
